## on the activities of the Committee on the quorum check

On the hour announced as the starting time of the extraordinary session of the General Meeting of the Shareholders of Enemona AD, Kozloduy town, namely 14.00 o'clock on May 15, 2013 the Committee on the quorum check found that the following categories of persons are present or are represented, respectively:

- 1. Shareholders natural persons /handwritten/ 6 198 166 shares with voting rights;
- 2. Representatives of shareholders, legal entities /handwritten/ 15 432 shares with voting rights;
- 3. Proxies of shareholders /handwritten/ 2 035 352 shares with voting rights;
