

REPORT
on the activities of the Committee on the quorum check

On the hour announced as the starting time of the ordinary session of the General Meeting of the Shareholders of Enemona AD, Kozloduy town at 11.00 o'clock on July 23, 2012. The Committee on the quorum check found that the following categories of persons are present or are represented, respectively:

1. Shareholders natural persons – /handwritten/ **223 531** shares with voting rights;
2. Representatives of shareholders, legal entities – /handwritten – scratched (as none)/ shares with voting rights;
3. Proxies of shareholders – /handwritten/ **7 038 694** shares with voting rights.

The total number of duly presented in compliance with the legislation and the Company Charter is /handwritten/ **7 262 225**, comprising /handwritten/ **60, 8553 %** of the shares with voting rights of Enemona AD. * (11 933 600 shares with voting rights in total).

The required quorum for holding the session of the General Meeting under art. 29, para. 1 of the Company Charter is more than half of all shares with voting rights of the Company.
